## TERMS AND CONDITIONS

### TICKETS

- Tickets purchased for the 2018 season are valid for travel through December 31, 2018.
- Tickets will convert to dollar value at the next ticket book sale or on December 31, 2018. Remaining dollar value may be used toward the purchase of new tickets at the prevailing rate.
- The ticket book discount is determined by the number of tickets purchased by a single account and may not be combined across multiple accounts.
- Ticket value is non-refundable. Value in accounts that are inactive for over one year will expire automatically.
- Itinerary changes are free outside of 48 hours before departure. Within 48 hours of departure time, changes may be made to flights on the same weekend in the same direction and when space is available.
- Cancellation within 48 hours of departure time will result in a forfeited ticket.
- Bookings made beyond available credit will be charged to the credit card on account at the prevailing single ticket rate.
- Pricing is subject to change at any time.

### AIRCRAFT DEPARTURE

Aircraft boarding will begin 15 minutes prior to the departure time. We cannot delay flights due to late arrival of passenger. Late arrival will result in a forfeited ticket. We will make best efforts to accommodate on another flight if space is available.

### AIRCRAFT

Tradewind Aviation Pilatus PC-12s are operated on this route. We reserve the right to substitute aircraft if necessary.

### BAGGAGE & CARRY-ONS

Every effort will be made to accommodate baggage. Each passenger may take 50 lbs. of luggage. In the event that weight is deemed excessive by the Captain some baggage may be transported on other Tradewind aircraft.

Pursuant to FAA regulations, all baggage, including carry-on's must be secured in the baggage area. Please plan your packing accordingly.

### BAGGAGE & CARRY-ONS (CONTINUED)

Federal law forbids the carriage of hazardous materials aboard the aircraft in your luggage or on your person. A violation can result in five years' imprisonment and penalties of \$250,000 or more (49 U.S.C. 5124). Hazardous materials include explosives, compressed gases, flammable liquids and solids, oxidizers, poisons, corrosives and radioactive materials. Examples: Paints, lighter fluid, fireworks, tear gases, oxygen bottles, and radio-pharmaceuticals. There are special exceptions for small quantities (up to 70 ounces total) of medicinal and toilet articles carried in your luggage and certain smoking materials carried on your person.

### PETS

Pets must be accompanied by their owner and appropriate documentation. Small pets in carriers that may fit on a lap are always welcome. A maximum of one family of larger pets is allowed per flight. Unforeseen circumstances (weather, etc) may require that more larger pets are combined on the same flight. We will do our best in these rare situations to accommodate everyone comfortably. If a pet is rowdy or doesn't like to play with other pets, we ask that it is placed in an appropriate pet carrier. Please notify the office to provide all pet names and weights at the time of booking. Pets in excess of 100 lbs require the purchase of a seat.

### WEATHER

Tradewind is certified to fly in most of the same conditions as scheduled commercial airliners. In certain limited circumstances, pursuant to federal regulations and/or safety, our aircraft will not be able to depart from, or land at our destination.

The decision to divert to another airport will be made by the Captain and will be made in the interest of safety. Passengers are responsible for any costs associated with alternative travel arrangements made necessary by the diversion.
